

RESOLUTION

AUTHORIZING THE EXECUTION OF A SHARED SERVICE AGREEMENT PURSUANT TO N.J.S.A. 40A:65-1 ET SEQ BETWEEN THE TOWNSHIP OF BRIDGEWATER, BOROUGH OF RARITAN, BOROUGH OF MANVILLE, AND BOROUGH OF SOUTH BOUND BROOK FOR THE PROVISION OF DAYTIME AMBULANCE SERVICES THROUGH THE ROBERT WOOD JOHNSON SOMERSET HOSPITAL

WHEREAS, the Township of Bridgewater, Borough of Raritan, Borough of Manville, and Borough of South Bound Brook desire to continue their association under the Somerset Ambulance Shared Service Agreement (SASSA); and

WHEREAS, the Agreement attached hereto as Schedule A renews the SASSA agreement pursuant to N.J.S.A. 40A:65-1 et seq. and authorizes Bridgewater to contract with Robert Wood Johnson Somerset on SASSA’s behalf; and

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Bridgewater, County of Somerset, State of New Jersey that the shared service agreement attached hereto as Schedule A is hereby accepted and approved; and

BE IT FURTHER RESOLVED, that Mayor Matthew Moench and Linda Doyle, Township Clerk are hereby authorized and directed to execute the annexed Agreement and take all appropriate measures to effectuate its purpose.

RESOLUTION

AWARDING A CONTRACT TO ROBERT WOOD JOHNSON HEALTH NETWORK, INC. ON A COMPETITIVE CONTRACTING BASIS FOR THE SOMERSET AMBULANCE SHARED SERVICES AGENCY (SASSA) FOR DAYTIME WEEKDAY AMBULANCE SERVICES, AT \$0 PER YEAR, FOR THE YEARS 2023, 2024, AND 2025

WHEREAS, the Township of Bridgewater, as lead agency for the Somerset Ambulance Shared Services Agency (SASSA) received proposals on September 18, 2019 for daytime weekday ambulance services for the years 2020, 2021 and 2022; and

WHEREAS, SASSA includes four (4) Municipalities in Somerset County, New Jersey; these include: Bridgewater, Manville, Raritan and South Bound Brook; and

WHEREAS, Robert Wood Johnson Health Network, Inc., the previous vendor for the past 15 years, was the only bidder; and

WHEREAS, the evaluation committee comprised of Bridgewater Deputy Administrator Wells Winegar, Bridgewater Director of Human Services Christine Madrid, and Sergeant James Edwards (Bridgewater Township Police Department – OEM) has met, reviewed the proposal and determined that the proposal submitted fulfills all of the requirements of the RFP; and

WHEREAS, the evaluation committee therefore recommends awarding the contract to RWJ Health Network, Inc. based upon Robert Wood Johnson Health Network, Inc.'s prior performance; and

WHEREAS, the Township of Bridgewater will be paying \$0 per year for daytime ambulance services, Monday-Friday, 6 AM - 6 PM, for the years 2021, 2022, and 2023; and

WHEREAS, the competitive contracting process as to notice, criteria and evaluation was reviewed and approved by Chris Corsini, Deputy Township Attorney, and the methodology, evaluation, criteria and award deemed compliant with the Statute by Christopher Corsini, Deputy Township Attorney, and Rose Witt, Qualified Purchasing Agent reviewed and approved the process with the award of the contract to Robert. Wood Johnson Health Network, Inc.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Bridgewater, that the proposal submitted by the Robert Wood Johnson

Health Network, Inc. Contract be accepted, and the Contract be awarded in accordance with the Proposal.

BE IT FURTHER RESOLVED, that this award of the Competitive Contract to Robert Wood Johnson Health Network, Inc. for the ambulance service will be summarized with the pertinent contents of the Contract and Linda Doyle, Township Clerk will publish the summary and award in the Township's official newspaper.
