MINUTES OF THE BRIDGEWATER TOWNSHIP COUNCIL <u>AUGUST 1, 2024 - COUNCIL CHAMBERS</u>

The Township Council of the Township of Bridgewater, County of Somerset, State of New Jersey, convened in a regular session on Thursday, August 1, 2024, at 7:30 p.m. in Council Chambers in the Municipal Complex, Bridgewater, New Jersey 08807 & via Live Online Broadcast.

Minutes

Council Reports

Councilman Kirsh:

 On July 19, 2024, Councilman Kurdyla delivered welcome comments at the Mental Health Awareness Forum sponsored by United for Impact and the Bridgewater-Raritan Youth Services Commission which featured six experts in the field of mental health. Councilman Kirsh stated it is important to have continued discussions on such matters and to provide resources for those in the community who are impacted by mental health and addiction challenges. Attended a tour of the Stavola Quarry which was hosted by Tom Branch on July 25, 2024. Councilman Kirsh stated it is a remarkable operation that is dedicated to being good stewards of the land, as well as being as efficient as possible.

Councilman Kurdyla:

- Attended two Open Space and Recreation Master Plan meetings.
- Councilman Kurdyla met with Township Administrator Pappas and OEM Coordinator, Jamie Edwards to discuss funding needs for township First Responders due to federal radio frequency changes that are being mandated for Bridgewater Township.
- Invited residents to attend 'National Night Out' being held on Tuesday, August 6, 2024, from 5:30 pm to 8:30 pm at the municipal building.

Councilman Norgalis: (verbatim)

- Township employees were treated to ice cream by Gabriels Foundation located in Martinsville. Two tables in the employee break room last week were covered with cups of delicious ice cream in eight different flavors and mixtures.
- I sat in on the interviews conducted by Township Clerk Grace Njuguna and Deputy Clerk Juliana Coelho to fill the administrative position in the Clerk's office. They selected Natalie Troisi, an internal candidate from the Tax Collector's office who has worked for the township for ten years. Good luck in your new job Natalie.
- The Township Administration is working to revisit the 50+ year sewer contract with Warren Township whereby we facilitate the pumping and piping of Warren sewerage to the Somerset Regional Sewerage Authority treatment plant located in Bridgewater. I spoke to Warren Mayor Victor Sordillo yesterday to reinforce the Council and Administration position already communicated to Warren via a letter by Admin. Michael Pappas that this issue needs serious attention. More to follow in late August on this matter.
- I hope that residents have seen the news release entitled "Bridgewater Township's efforts to protect resident's emails ends with "Victory". Last week the State Supreme Court dismissed the appeal by an organization called Rise Against Hate seeking to gain email addresses for residents who signed up for township email. In my opinion, this was simply their effort to broaden their marketing base.
- Bridgewater Township Police Department's National Night Out is scheduled

for Tuesday, August 6th at 5:30 pm at Bridgewater Municipal Complex.

Councilman Pedroso:

Councilman Pedroso read the following statement:

I am deeply saddened to address a troubling incident that occurred last week. Someone defaced a pillar of the mosque at the Al Fatah Center in Bridgewater with hateful, anti-Muslim graffiti. Such acts of bigotry and discrimination against places of worship are utterly unacceptable and must not be tolerated.

The United States was founded on the principles of religious freedom, championed by pilgrims who risked their lives to practice their faith without persecution. Our forefathers enshrined the right to religious liberty into the very fabric of this nation. These fundamental values are so intrinsically fair and just, and it's unfortunate that I even have to talk about them today.

Bridgewater Township is a vibrant, diverse community where individuals of all races, colors, and religions coexist. It is essential that everyone feels welcome here. Let me be clear: Bridgewater stands united against hate. We will not allow the despicable actions of a few to tarnish the welcoming spirit of our community. Our Muslim friends, along with all religious groups, should know that they are respected and embraced in Bridgewater.

In 2016, as Council President, I broke tradition by inviting representatives from all four major religious groups in town to offer prayers at our Council reorganization meeting. This gesture was meant to convey a powerful message: Bridgewater celebrates its diversity, condemns discrimination, and is a place where everyone belongs.

Today, I reiterate that same message, and I hope it's loud and clear.

I must also address a recent issue involving false accusations of discrimination. A.J. Joshi, a Board of Education member, who was the keynote speaker at the Bridgewater-Raritan High School graduation, falsely claimed that his son was racially discriminated against by the Bridgewater Police Department. Chief John Mitzak presented findings from the Somerset County Prosecutor's Office at our last Council meeting, revealing that no misconduct occurred.

When Mr. Joshi initially brought these accusations before the Council, I was deeply concerned. Our police department is exceptional, and such serious allegations warranted attention. However, after reviewing the police body camera footage, it is clear that Mr. Joshi misled this governing body. The officer involved acted with professionalism, sympathy, and courtesy.

False claims of racial profiling or discrimination are a grave disservice to our community and the cause of equality. These lies not only undermine the integrity of our police department but also sow division and distrust. By fabricating victimhood, Mr. Joshi disrespects the genuine struggles of individuals who have faced real discrimination. His actions dishonor the legacy of civil rights heroes like Rosa Parks and Dr. Martin Luther King Jr. and diminish the credibility of those with legitimate grievances.

Mr. Joshi's conduct demands accountability. He should apologize to the Bridgewater Police Department and our community for the harm and division he sought to create. Our society cannot afford leaders who undermine the fight for racial equality and disrespect the true victims of discrimination. Our children deserve better role models. Mr. Joshi should resign from the Bridgewater-Raritan Board of Education immediately.

Let us stand together as a community, united in our commitment to justice, equality, and respect for all. Thank you.

Mayor's Reports

Michael Pappas, Township Administrator reported on behalf of Mayor Moench

- A memo was distributed to the council from Township Engineer, Bill Burr regarding PSE&G's extensive gas main replacement throughout Bridgewater. Also, attached was a map of ten roads that will be paved, curb to curb, over the next few weeks.
- Township Administrator Pappas circulated a memo and photographs regarding the successful installation progress of the turf field replacements which should be finished by the end of next week.

Denise Rinn – 2 Hayward Street, Bound Brook, NJ 08805

Ms. Rinn expressed concerns regarding vehicles speeding and not obeying street signs near Shady Lane Park. She stated that her daughter reached out to the township but had not received a response. She requested a study be conducted and gave suggestions on how to alleviate the problem.

Ms. Rinn stated there is use of marijuana, as well as vaping, in the township parks and asked that this be monitored. She also stated that there was an issue with mosquitos in her neighborhood.
