## DUTIES AND RESPONSIBILITIES

The Division of Public Works is seeking a full-time laborer to perform routine work maintaining township property including but not limited to sewer system maintenance, road maintenance, buildings and grounds, and parks. This involves outdoor work in all-weather conditions involving manual labor including but not limited to sewer system maintenance, road maintenance, grass cutting, weeding, park maintenance, snow plowing, leaf and brush pickup, tree work and other related duties. Report for all emergency work including snow and other emergency work (on 24-hour call) as required by Superintendent of Public Works or designee.

## MINIMUM REQUIREMENTS

- High school diploma or equivalent.
  - Experience in sewer system maintenance, including but not limited to jet vac truck and sewer camera system operation, troubleshooting, etc.
  - Experience performing heavy manual labor in adverse weather conditions.
  - Must have experience operating a backhoe
  - Valid NJ Driver's License is required.
  - Sewer Collection Level 2 License preferred.
  - CDL Class A not required immediately but must be obtained within 6 months of hire.

## SUPPLEMENTAL INFORMATION

**Authorization to Work:** US citizenship is not required. Selected candidate must be authorized to work in the US according to Department of Homeland Security, US Citizenship and Immigration Services regulations.
